

TERMS & CONDITIONS: AUDI FOUNDATION PRIZE DRAW 004

ELIGIBILITY CRITERIA

HOW TO ENTER

2. retain the Eligible Purchase's purchase receipt (**Purchase Receipt**); and

WINNER DETERMINATION
